# CAMDEN COUNTY BOARD OF COMMISSIONERS MEETING June 17, 2021

# 520 Market Street 6<sup>th</sup> Floor Conference Room Camden, New Jersey

The meeting was called to order by Director Cappelli at 12:00 p.m.

The Clerk called the roll and the following Commissioners answered:

Due to the Coronavirus pandemic, the meeting was closed to in-person participation by the public. The public was availed the opportunity to participate via live streaming and to send in questions before, during and after the meeting.

The Director stated that adequate notice of this meeting has been provided in accordance with the Open Public Meetings Act.

The Director asked everyone to rise for the Pledge of Allegiance.

The Director said good afternoon ladies and gentlemen. Welcome to the meeting of the Camden County Board of Commissioners.

## **PROCLAMATION**

Commissioner Young presented a proclamation recognizing the celebration of Juneteenth. He said Juneteenth is this Saturday. He thanked the Board for their continued support of the African American community as well as the support they provide to himself and Commissioner Dyer in their ventures. Juneteenth is the day that slaves were freed in 1862. As a Board we would like to recognize Juneteenth as a holiday. This morning President Biden signed a law making Juneteenth a federal holiday. Some people question why African Americans ask for so much and why we feel we need so many different things. When America was being built, you had two groups of people - African Americans and slave owners. America was built on the backs of slaves. I do not think we are asking for anything that is too much. We were a part of this in the beginning. I think we are just asking for our just due recognition. In the last year there has been more and more talk about making sure that the correct history is being told. It is important that we understand our history. Again, I would like to thank the Board for their support. Commissioner Young concluded be reading a portion of the proclamation, as follows: "Juneteenth is an annual event recognized by some for a day, week or even a month. No matter the length of the celebration, Juneteenth is always a period of reflection and rejoicing for African American people. Juneteenth

celebrations everywhere have grown in popularity bringing people of all races, nationalities, and religions together to acknowledge a period in American history that has helped to shape and influence our society.

## **COMPTROLLER'S REPORT**

The Director asked for a motion to adopt the Comptroller's Report. Deputy Director McDonnell made a motion with a second by Commissioner Young and on roll call all Commissioners present voted aye.

## **CORRESPONDENCE**

The Director asked the Clerk if there was any correspondence. The Clerk responded that there was not any correspondence this month.

The Director said the next portion of the meeting is open to the public for discussion of resolutions to be acted upon this afternoon. There will be another public hearing later in the meeting at which members of the public can ask any questions they want regarding the business of the County of Camden. This portion is limited to the discussion of those resolutions to be acted upon. The Director opened the public hearing.

Kate Delaney, 126 E. Palmer, Collingswood had the following questions and comments:

**Question #1** – Resolution No. 30 What are the names of the people being appointed to the Open Space Preservation Trust Fund Commission? Commissioner Nash said Vedra Chandler of Camden and Jack Sworaski, recently retired, from Pennsauken.

**Question** #2 – Resolution No. 37 What are the names of the people being appointed to the Mental Health Board? Commissioner Rodriguez responded that Nancy Cruz is being appointed and we are reappointing all previous members of the Board.

**Question** #3 – Resolution No. 52 What are the names of the people being appointed to the Workforce Development Board? Commissioner Young responded Ryan Doran, Robert Regensburger, and Rosa Martinez are being reappointed.

**Question** #4 – Resolution 85 authorizing the use of Competitive Contracting Request for Proposals, pursuant to N.J. S.A. 40A: 11-4.1 et seq., for Homeless Shelter Operator Services for the Camden County Department of Community Development. *Ms. Delaney requested more details on the RFP including the type of services and location.* Director Cappelli responded that

the RFP has not yet been developed. This Resolution authorizes the use of an RFP to procure these services. The RFP will be published on June 23<sup>rd</sup>.

Question #5 – Resolution No. 89 amending the 2021 Table of Organization. What changes have you made to the County Table of Organization and where can the public view this information? DCA Holly Cass responded that this Resolution corrects a typographical error and moves oversight of the Mosquito Commissioner from Commissioner Dyer to Commissioner Nash. The County Administrator commented that the Table of Organization is available on the County website.

Comment #6 – Resolution No. 17 urging the Secretary of the Navy to designate the Delaware River as the site for the celebration of the 250th anniversary of the Navy and the Marine Corps. Months ago, the South Jersey Progressive Democrats asked you to pass a resolution urging protection of the Delaware River from a dangerous fossil fuel project still in the works. At the time, you said it was beyond your jurisdiction. It's disappointing to me that passing a resolution to include the Delaware in a celebration is more of a pressing concern for our county commissioners than actually protecting the tidal river we all live adjacent to.

**Question** #7 – I would like more information on the walk-on resolution presented at this months Caucus. Director Cappelli said I am not familiar with which walk-on resolution you are referring to.

Hearing no other members of the public wishing to comment, the Director asked for a motion to close the public hearing. Commissioner Nash made the motion with a second by Commissioner Young and all Commissioners present voted aye.

The Director closed the public hearing.

# **RESOLUTION 99**

#### **NO MOTION MADE – FAILED**

Director Cappelli opened the meeting to any member of the public who wished to address the Board of Commissioners.

Seeing no members of the public wishing to comment, Director Cappelli asked for a motion to close the public hearing. Commissioner Nash made a motion with a second by Commissioner Young and all Commissioners voted aye.

The Director opened the floor to the members of the Board of Commissioners for their comments.

Commissioner Nash said I am proud of the County for recognizing Juneteenth and the significance of the holiday. Thank you, Commissioner Young, for bringing that Proclamation. People need to understand why this day is being recognized as a national holiday. It is recognizing the end of slavery. If you look at the history of this county and understand that the Emancipation Proclamation was actually an Executive Order in 1862 and did not end slavey. That Executive Order by President Lincoln was just that, an executive order halfway through the Civil War. It was the Civil War that technically ended slavery, but it did not end racism. As everyone who is educated about this County's history knows, racism has survived through all these years. Neither a proclamation nor war can end racism. It is going to take education, a fight for social justice, and efforts to offer equal opportunity that slowly unwind something that is a stain on this country. I do appreciate the proclamation and the recognition by this County, and it is very important.

Commissioner Nash said I would like to recognize the people in the Parks Department and Special Events who have reconnected the public with our concert program. The concerts are now at Wiggins Park, Cooper River Park, and the Dell. The crowds have been enormous. At the Dell last night and two weeks before, it was standing room only. The music was great. Roland Traynor has done an amazing job once again. He started off where he left off and that is presenting great entertainment. They are also offering vaccinations to residents who want to be vaccinated and that has been very successful.

Commissioner Nash said I would also like to recognize that this is the last meeting of our County Counsel, Chris Orlando. I have been a Commissioner and Freeholder for many years, and I have worked with many county counsels. Chris Orlando is perhaps the best. I am sorry to my

friends who have preceded you. You are certainly one of the best counsels I have ever worked with in any level of government that I have been involved in. You are not only super smart and caring and compassionate, but you know how to get things done. You were also very successful as the Executive Director at the Improvement Authority. This is an enormous loss for the County. No one is irreplaceable but you are indispensable. We are going to miss you and I want to thank you for your many years of service to the residents of this County.

Commissioner Young said thank you for your kind words, Commissioner Nash. On Saturday we will have our Juneteenth Celebration starting at 1:00. The motorcade will end up at Wiggins Park where we will have some celebrations.

We have food distribution tomorrow in Lindenwold. We have an old partner who has come back into play. We have partnered back with Farmers Against Hunger. We have fresh produce coming right off the farms to those in need. We will be at the Charles DePalma Complex in Lindenwold from 10:00 until 12:00 or until the food runs out.

The Animal Shelter is running a Father's Day Special. It is \$25.00 for adoption fees. Come on down and get yourself a puppy.

Last but not least, I failed to recognize two of our officers. We have two canines in our jail. They participate in a national competition every year. Right before the pandemic hit, they competed in a competition and finished in 3<sup>rd</sup> place. Third place is good but here in Camden County we are used to 1<sup>st</sup> place, so I challenged these two officers to see what they could do. Because of COVID they had an extra year to train. I am happy to say that nationally, Camden County Correctional Canines, Sasha and Jax are the number one first place dogs in the competition out of 105 teams. Sgt. Kane and Officer Tucker are two outstanding officers. Congratulations to them.

Thank you to all our employees in Camden County. Happy Father's Day to all.

Commissioner Rodriguez said I would like to acknowledge the importance of celebrating Juneteenth and knowing what the history of the African American community is. Black Culture should be 365, every day. It is part of our history and should be weaved into our everyday life, not just one month. I would like to commend the Camden County Historical Society who has been championing this cause. Through the Historical Society we have had three slave markers placed throughout the city marking points where slaves came into the Camden County area. We are also in the process of developing a rain garden in the honor of slaves at Pomona Hall in Camden City. We have the names of eight different slaves who lived there. We need to do this more, throughout the year. Not just in February, not just Juneteenth but a flag raising, acknowledging the true history. I have it under good information that New Jersey was actually the last state to still have slaves. Slavery had not ended here. In the northern region, New Jersey was the last state to actually outlaw slavery.

I would like to encourage everyone to get outside. We have very significant concerns coming back so we must continue to protect ourselves. But the lack of social interaction that many individuals had over the past year is something that had a major impact. As the Health Department continues its vaccine effort, we are going to start shifting our focus to addiction and mental health because that is what we are seeing as the next crisis. It is summertime. The Governor raised the

restrictions outside so get outside, get some sun, go for a walk. We have many beautiful parks. Come and enjoy them.

**Commissioner Kane** said I would like to thank my colleagues for their comments concerning Juneteenth and in particular Commissioner Young for his honest and sometimes painful remarks in saying what comes from his mind and his heart.

Commissioner Kane said I would like to talk about Resolution No. 17 which urges the Secretary of the Navy to designate the Delaware River as the site for the celebration of the 250th Anniversary of the Navy and the Marine Corps., officially called the Semiquincentennial. 2025 will be the 250th anniversary. The birthplace of the Navy and the Marine Corps is the Philadelphia area. We are urging the Secretary of the Navy to designate New Jersey, Philadelphia, and Delaware as the main celebration area in the United States. The planning committee is already working very hard on this event even though it is four years away to make sure it is in this area and brings the opportunities for tourism, dollars, and recognition of the deep history to our area.

Commissioner Kane continued by saying June is PTSD Awareness Month. This is to reduce the stigma of PTSD and to ensure that those suffering from the invisible wounds of war, accidents, and assaults receive the proper treatment that they need. In terms of the military, PSTD was first acknowledged in 50 BC by Hippocrates who talked about soldiers returning from battle. Previously it had been known as "shell shock" or "battle fatigue" and renamed PSTD after Vietnam. There are some events going on in our county to raise awareness of PTSD.

Finally, Camden County Cultural and Heritage Commission is having their annual art show, Countywide. The winners of the art show will move on to the State competition because the State competition this year is virtual, as is the County competition. The artwork will be exhibited at the Rohrer Center on Route 70 in Cherry Hill after the winners are announced. Entries are due by June 28<sup>th</sup>. Commissioner Kane encouraged any artist who is interested in submitting their work to do go on our website for more information.

Director Cappelli thanked Commissioner Kane on her leadership to have the Delaware as the site of the Semiquincentennial Celebration.

Commissioner Dyer said I would like to recognize Jon Young for getting out front with Juneteenth. It is painful but we have to talk about our history. Commissioner Dyer recognized the Department of Public Works. He said a lot of times they get recognition for their work in the winter months but during the summer we don't always talk about their projects. They are currently working on the following projects: Lower Landing Road has been completed in Gloucester Township, Eastown Road construction has begun in Winslow, as well as the widening of Cross Keys Road in Winslow, Pine Hill and Berlin, the Haddonfield/ Sorrell Road construction project in Pennsauken, Park Avenue in Pennsauken will start shortly, Center City in Merchantville has begun, the Woodcrest Bridge construction has been completed and the Kaighns Avenue dam repairs are ongoing. Line striping is ongoing. Please continue to be careful as you travel.

Commissioner Dyer said earlier today I was fortunate to attend the announcement of the second round of funding for renter's assistance. \$15 million has been allocated to help our renters. This is dear to me because growing up we were evicted 5 or 6 times. Whenever the county can provide money to help folks with a little more time to help them get ahead it is a good thing. I

would like to thank Dan Keashen for helping me get in front of this issue. It is a great program for the County to allocate money for renters.

In closing, Commissioner Young wished Commissioner Rodriguez a Happy Birthday.

**Deputy Director McDonnell** said I would like to add to what others have said by thanking Jon Young for keeping us and our county up on social justice. It is a very important thing and sometimes we are not as conscience of it as we should be.

Jeff Nash said pretty much everything I wanted to say about Chris Orlando. Chris, we are going to miss you. You have been such an outstanding county counsel. You have done a superb job. I speak not just for myself but for Lou who works closely with you and Ross Angilella, our County Administrator who spends many, many hours with you. Your contributions beyond the legal expertise and helping us formulate and execute policy has been just wonderful. I am very disappointed you are leaving; however, I wish you well in your new endeavor. You were a great county counsel and I thank you for that.

**Director Cappelli** said thank you Commissioner Young. For many June marks the start of the summer. For others, June is a month of acknowledgement and liberation. Today Commissioner's Young proclamation marks its importance. President Biden signed legislation this morning, so it is officially a federal holiday. The last federal holiday was established in 1983. I think the nation is, hopefully, starting to come to grips with its past and acknowledging publicly what we all know. As Commissioner Nash said, education is the key to moving forward.

This month was also National Pride Month. We have participated in many activities throughout the county. There will be more. No matter what you celebrate or how you feel, you are welcome in Camden County and the Board of Commissioners is here to recognize those occasions with you. Again, on Saturday at 2:00 at Wiggins Park, community partners will be coming together to recognize and celebrate Juneteenth.

The Director said, I echo everyone's thoughts and comments regarding Chris. As a Commissioner we rely on county counsel not only for legal advice as issues arise throughout the County but also for protection and guidance in this complicated legal world. It has never been more complicated to be a public official and it really takes an outstanding county counsel to make sure we are moving in the right direction, not only legally but in policy matters as well. It is very reassuring to know that someone with your talent is standing behind us. It is invaluable to all of us. Your work at the Improvement Authority as well has been outstanding. Again, we are disappointed but wish you the best of luck in your endeavors.

Chris Orlando said before I took this job I went and had coffee with Judge Silverman Katz who was county counsel a couple before me. She told me at the time that it was her favorite job she ever had and ever since she left she has missed it, but it was time to go. She was dead on! Mr. Orlando said I cannot thank the Board enough for giving me this opportunity. What the Board does and the policy that it sets along with Senior Administration and the employees of Camden County is really incredible. The work that gets done is amazing. This last year has highlighted it with all hands on deck for the testing and vaccines but that is just a microcosm of what this Board has been and what this group of people does every single day. It has been an honor to work for this Board. I cannot thank you enough. I loved every single day I have been here, and I look

forward to working with you in my new role. I truly appreciate this opportunity. Thank you very much.

The Director asked for a motion to adjourn. Commissioner Young made a motion with a second by Commission Dyer and all Commissioners voted aye.

The meeting was adjourned at 12:34 p.m.
